GENERAL INFORMATION

Te Forum will be held from 23 to 26.06.2020 in the International Home of Scientists “F. J. Curie” at the “St. St. Constantine and Helena” Seaside Resort, VARNA, BULGARIA.

1. **Official Languages:** Bulgarian & English.
2. Applications for participation are made by sending the attached forms as follows: **Form “A”** - for all attendants, full text paper at the Forum - to be received until **15.04.2020**; **Form “B”** - for all attendants, regardless presenting or not a paper - to be received **till 15.05.2020**.
3. Two copies of the **Summary** of the report in **English** should be attached to **Form “A”**. This Summary should be on one standard type written page and should include: author’s full name, scientific degrees and academic titles; Main objectives of the paper; Study main results and contributions.
4. The papers should not exceed 6 type-written pages in MS Word 6.0 with Times New Roman font, single line spacing, 1,2 cm indentation of before new paragraph and 2 cm margins on both sides. On the top of the first page with capitals font size 18 pt Bold, Alignment centre, should be written ENERGY FORUM 2020. After one wide line, should be the title in Bulgarian with capitals, font size 14 pt Bold, Alignment centre. After it should be posed the name of the authors with font size 12 pt, Alignment centre and Spacing after 30 pt. The names in English with font size 12 pt, Alignment centre and spacing after 30 pt. The title of the paper should be in English with capitals, font size 14 pt bold, Alignment centre. The names of the authors should be in English, font size 12 pt, Alignment centre and spacing after 30 pt. Next, there should be briefly summarized in English - 5-6 lines with font size 11 pt Italic, Justified.

The papers should contain introduction, presentation, example, conclusion, literature and at the end - the names of the author/authors with their scientific

degrees and positions, workplace, telephone, e-mail. The titles of the parts should be written with font size 14 pt bold, Alignment Justified, Spacing before 6 pt, After 3 pt. The other titles should be formatted with font size 12 pt bold Italic, Alignment Justified, Spacing before 6 pt, After 3 pt.

Every formula should be written with Equation editor. The properties for the symbols are: full 12 pt, Subscript/Superscript 8 pt, Sub-Superscript/Superscript 5 pt, Symbol 18 pt, Sub-Symbol 12 pt. The formulas should be numbered in brackets, alignment right. The sign under the figure should be formatted with font size 12 pt, Alignment centre, Spacing before 3 pt, After 6 pt. The tables should have numeration, Aligned right with font size 12 pt, Alignment center. The font in the tables should be 11 pt or 12 pt. The mentioned in the text literature should be marked with numbers in medium brackets. The font of the list of the literature sources should be 10 pt.

The full text paper in digital version should be sent to e-mail: ntseb@abv.bg and should be received until 15.04.2020. The organizers are not responsible for the printing of papers that have not been received in due time.
